BOARD OF TRUSTEES

Held: June 29, 2010

Bowling Green Township Board of trustees opened this regular meeting at 7pm with roll call. All trustees and ^{present} Fiscal Officer arrived late.

ZONING INSPECTOR Zoning inspector turned into the trustees a report on several junk cars in the township. She would also like to request the fiscal officer's computer when the FO receives the new one.

Comprehensive Plan Committee Patty Volland reported the committee collected 168 survey. The written comments were entered into the computer with the rest of the information but the comments were not sent with the results from the survey. A couple of things that showed to be important to the residents are: Preserve farmland and historic sites, ramps on and off 70 at 668. Michael will talk with Soil & Water about having a meeting on preserving farmland. Several responses also said they would like to see the township send out a newsletter.

PARK COMMITTEE

UNFINISHED BUSINESS Trustee VanBuren talked to George Uffner, part owner of the old post office building. He said he would agree with taking the building down if the twp was able to get a grant. Trustee Hupp talked to the prosecutor about the process and the foreclosure has begun. The property should be sold or go up for sheriff's auction by the end of the year.

Brownsville resident asked what has been done to the alleys. Trustees explained they are trying to prepare them for chip and seal, which should be done in 2 or 3 weeks.

Trustees discussed the new truck purchase. Trustee VanBuren said Madison Twp in Perry Cty would like to purchase the old truck. Trustee VanBuren said he spoke to the prosecutor and the twp does not have to put the truck out for bid if they are selling it to another township. Trustee VanBuren made a motion to sell the GMC truck to Madison Twp in Perry Cty for no less than \$7500.00. Motion seconded by Trustee Watkins. All in favor.

Trustee Watkins made a motion for to put a total of \$10,000 down on the purchase of the new truck, \$7500 from the sale of the truck and \$2500 from township funds. Trustee VanBuren seconded the motion. All in favor.

NEW BUSINESS

PUBLIC COMMENT

Will Kern asked if the trustees planned to put something over the #2's that were put on the cul-de-sac. Trustees will spread something over it to smooth it out some.

Bob Wess asked how long he can park auction items by the road. Zoning inspector said 30 days prior to the auction.

Trustee VanBuren made a motion to pay the bills; sign purchase orders and blanket certificates, and the bank statement. Trustee Watkins seconded the motion. Motion Carried. It is lawfully certified that the amount \$17,476.75 is lawfully appropriated to pay the bills by the fiscal officer.


