

The zoning inspector reviewed a couple of cases that are still open. JC001-12 for address 10503 Open Woods RD. Resident had 10 vehicles to remove. Trustees previously gave resident a 90 extension. He has removed 4 of the vehicles. Resident is having trouble finding the owners of the vehicles. Tr. Hupp made a motion to give resident 90 more days to remove vehicles. Tr. VanBuren seconded the motion. Roll Call: VanBuren yes, Hupp yes, Chorpenning absent.

Case JC 004-12 for address 11784 Midland Oil Rd. Residents keep moving vehicles from one location to the other. Neighbors would like something to be done. Zoning inspector would like to further review this case. Trustees agreed to leave it open for further investigation.
