BOARD OF TRUSTEES

Held August 27th, 2013

Bowling Green Township Board of trustees opened this regular meeting at 7pm with roll call. Trustee Hupp and Trustee VanBuren were present, Trustee Chorpenning was absent and Fiscal Officer (FO) Duval was present.

CORRESPONDANCE FO Info on new gravel company, notice from Licking County planning commission about a hearing on text amendment on 3.1: minor land division criteria and section 4.51: lot standards, and section 11.31: fire protection of the subdivision, land division, development and congestion prevention regulations for Licking County. 




Trustee VanBuren made a motion to adjourn the meeting. Motion seconded by Trustee Hupp. With business complete the board adjourned at 7:35pm.
