#### **GUEST SPEAKER**

<u>CORRESPONDANCE</u> FO received a letter from Vickie Fogarty, chair of the park committee, stating she is resigning her position. Trustee Watkins said he went to the last park committee meeting and apologized to the committee about comments that have been made in the past. Vickie said she will consider not resigning.

Trustee VanBuren received a quote to move the lights on the truck.

#### **NEW BUSINESS**

All 3 fire departments were present to discuss the fire contracts with the trustees. Fire Chief Ted McNamara from National Trails Fire Department said they are satisfied with the contracts. National Trails had 93 runs so far for 2010. Ed Sickles from Hopewell Township Fire Department said they are also satisfied with the contracts. Their department had 58 runs, 20 of those were on the interstate. Mr. Sickles will be the new Chief beginning on January 1. Chief Mike Wilson from Licking Township Fire said they are also satisfied with the contract. They had 74 runs. Trustee Watkins made a motion to accept the fire contracts for 2011. Trustee VanBuren seconded the motion.

#### **REPORTS**

Comprehensive Plan Committee Michael Pitcher reported from the committee's last meeting. Since the fire departments were present, he mentioned the committee isn't sure what do to about the fire departments in the plan. Committee decided to not meet in November and December due to the holidays. Their next meeting will be in January 18. Matt Hill LCATS completed the road survey and has forwarded his findings onto ODOT. Because of his survey, ODOT D5 has applied for "High Risk Rural Road Funding" that would purchase improvements that increases driver visibility on the Rt 668 roadway.

## **UNFINISHED BUSINESS**

Trustee VanBuren stated that employee Jack Hedges watched a safety video on the internet to fulfill his requirement. The video was on Safety Videos Now.com and it was called Safe Operations of Motor Vehicles 17 minute preview.
