PUBLIC COMMENT

Barb Selegue asked the trustees to look at Cherry Hill Road before winter.

Dee Krier asked if the no soliciting signs that are posted on Carmel CT means the kids couldn't sell their school fundraising items. Trustees explained that the no soliciting applies to door to door salesman not school fundraising.
