## **PUBLIC COMMENT**

Dee Krier said she was following a trash truck down Linnville Road. It only had one guy in the truck to pick up and drive. She said he almost got hit but traffic trying to pass the truck. She asked if something like that happened in the township would the township be held liable since they contracted with the trash company. Trustees don't feel they would be held responsible.

Mike Fields lives on Somerset Rd and said there are trash trucks coming by his house 3 days a week so the single trash hauler contract has not reduced the amount of trucks on the road. He was also questioning who made the mess on the road in front of his house and when will it be cleaned up. Trustee Watkins said it doesn't need cleaned up.

Will Kern requested the receipt from the repair on the new truck.

Jeff Chorpenning asked if the other trash hauling companies where ever notified that the single trash hauler contract was awarded to Big O. FO said it was her understanding that Big O would be taking care of contacting the other companies.

Bob Wess said he talked to Trustee Hupp at the last meeting about the problems he had with the zoning inspector and would like to know if anything was done. Trustee Hupp said he spoke to the zoning inspector about it.

Vickie Fogarty said CMI is still trying to pick up her trash even though she has cancelled with them. FO said she is working with the prosecutor on a letter to send to the trash company.

Don Monroe said all the residents in Dogwood appreciate the change in trash companies.
