<u>GUEST SPEAKER</u> John Parker from Gardner Parker Insurance stopped in to see how things are going and if board had any problems or questions. Tr. Chorpenning talked to Mr. Parker about the recommendations from the risk management company. Mr. Parker said those are just recommendations and not requirements. Tr. Chorpenning will mail in response to recommendations.

CORRESPONDANCE Tr. Chorpenning had a couple of things in the minutes from Sept 11, 2012 meeting that needs corrected.

REPORTS

<u>FIRE</u> Resign contracts for Licking Twp due to date error.

ZONING INSPECTOR Barb Selegue said she will need to re-mail the notice to Stepp because the post office doesn't have a receipt on it. Barb asked for a 30 day extension for the 16246 Laurel Rd situation. The property owners are working on it with Barb and the county prosecutor and need more time. Tr. VanBuren made a motion to give the Wess' a 30 extension, until January 1st. Tr. Hupp seconded the motion. Roll Call vote: VanBuren yes, Hupp yes, Chorpenning yes. Wess' turned over paperwork and a check to Barb to apply for a variance on lot splits.

Zoning Appeals There was a member that could no longer be on Appeals board. Dusty Levingston, formally an alternate, was moved to the open permanent position.

PARK COMMITTEE No report

UNFINISHED BUSINESS

Tr. Hupp explained what he found out about drug testing. Company Care charges \$55 for urine test. Alcohol test is \$25. IForce in Newark is \$25 for urine test. IForce said they would just need to set up an account. Tr. Chorpenning made a motion to use Iforce in Newark for drug or alcohol testing. Tr. VanBuren seconded the motion. Roll Call vote: VanBuren yes, Hupp yes, Chorpenning yes.

Tr. Chorpenning talked to Kurt Simross about some changes that need to be made to the road grant application to improve our chances on receiving the grant. If the township raised the percentage of our portion to 26%, this will raise our points. Also if the estimate is changed from 2" to 1 ¼" of asphalt, this will lower the cost of the project from \$240,000 to \$152,000. Tr. Chorpenning made a motion to modify the grant by changed our share to 26% and to change asphalt from 2" to 1 ¼". Tr. VanBuren seconded the motion. Roll Call vote: VanBuren yes, Hupp yes, Chorpenning yes.

NEW BUSINESS

Tr. Chorpenning made a motion to move Dustin Levingston into an open alternate postion on the zoning appeals board. Tr. VanBuren seconded the motion. Roll Call vote: VanBuren yes, Hupp yes, Chorpenning yes.

Tr. Chorpenning asked how Sam Allen became an employee. Tr. VanBuren and Tr. Hupp said they need spot labor. Tr. Chorpenning said he knows what do to if he needs some help. Tr. Hupp said they got a consensus of the majority of the board that they was what they needed to do, so just make sure that happens.
