Mike Vermillion said the members all had good intentions at the time but participation has dwindled.

Trustee Chorpenning said that the board decided to micromanage the park committee so what could they do? Trustee Hupp said all they had to do was make recommendations to the board but they didn't even do that. Trustee Chorpenning said they have accomplished quite a few things.

Barb Selegue said the have done several things but they have also done some damage. They removed the merry go round when the residents of the township didn't want it removed. Patty Volland said they had no authority to spend the money. Geary said they could have stopped it. Trustee Hupp said it was installed before they even knew about it.

Trustee VanBuren said the reason the park committee was started was because Will Kern was complaining about the cost of the utilities but that has never happened. They still don't make enough to cover utilities. Should just go back to the way it was when everyone just pitched in to help.

Mike Vermillion said it started for good reasons but he feels it has turned political, mainly because of Jeff Chorpenning.

Sally Bryan asked if the fiscal officer sent a letter to all committee members. Fiscal officer said she did.

Mike Vermillion hopes he park committee doesn't feel like they are bashing them, he appreciates all them have done. Trustee VanBuren and Hupp agree.

Trustee VanBuren made a motion to give the responsibility back to the community and disband the park committee effective January 1st. Motion seconded by Trustee Hupp. Roll Call vote: VanBuren yes, Hupp yes, Chorpenning no.

Trustee Chorpenning moved to adjourn. There was no second. Trustee Chorpenning suggested contacting legal counsel before anything new is established. Trustee Chorpenning moved to contact legal counsel. There was no second to the motion.

Trustee Hupp requested the fiscal officer send a letter to all park committee members informing them the park committee has been disbanded but all members are still encouraged to participate.

Sally suggested purchasing a new refrigerator to replace the old one that is not working right.
