Held November 18, 2014

Bowling Green Township Board of trustees opened this junk car meeting at 7pm with roll call. Trustees VanBuren and Trustee Hupp were present. Trustee Chorpenning was absent. The Fiscal Officer (FO) was also absent.

VISITORS: Barb Selegue, zoning inspector

Zoning inspector states there are 6 cases to review. These all came to her attention from a phone call she received in June. She has been watching the properties since then. She started taking photos in August

First case is JC011-14 with address of 16184 Laurel Hill Rd. There is a yellow and black 2 door vehicle believed to be a AMC Gremlin. The hood is open, there are no plates, excessive rust, tires are flat and the vehicle has been in the same location for over 90 days. Trustee Hupp made a motion for the zoning inspector to proceed with sending the resident a letter requesting the residents remedy the situation. Case will be reviewed at December 9th meeting. Trustee VanBuren seconded the motion. Roll Call vote: VanBuren yes, Chorpenning absent, Hupp yes.

The second case is JC012-14. The address is 16421 Laurel Hill Rd. There are 2 vehicles on this property. One is a white Ford f150 with flat tires, has junk in the bed, the plates are outdated and has not moved in over a year. The second vehicle is blue with black top, possibly a Mustang; tires are flat and have not moved in over a year. Trustee Hupp made a motion for the zoning inspector to proceed with sending the resident a letter requesting the residents remedy the situation. Case will be reviewed at December 9th meeting. Trustee VanBuren seconded the motion. Roll Call vote: VanBuren yes, Chorpenning absent, Hupp yes.

The third case is JC013-14. The address is 11616 Laurel Hill RD. Black Blazer in an open field. Vehicle was too far to determine damage. The complaint is from the same call in June so the zoning inspector had to investigate but doesn't feel this property has junk vehicles. Trustee Hupp said to check on it again in January to make sure the vehicles are not still sitting in the same location.

The next case is JC014-14. The address is 12210 Rankin RD. There is a blue GMC truck with junk in the bed, bricks in front of the vehicle, flat tires and parked behind 2 other vehicles. The vehicle has not moved for over 90 days. Trustee Hupp made a motion for the zoning inspector to proceed with sending the resident a letter requesting the residents remedy the situation. Case will be reviewed at December 9th meeting. Trustee VanBuren seconded the motion. Roll Call vote: VanBuren yes, Chorpenning absent, Hupp yes.

Case JC015-14 at address 12018 Rankin RD. There is a white vehicle located in the front yard. Plates are outdated, grass has grown up around and the tires seem to be flat. Trustee Hupp made a motion for the zoning inspector to proceed with sending the resident a letter requesting the resident remedy the situation. Case will be reviewed at December 9th meeting. Trustee VanBuren seconded the motion. Roll Call vote: VanBuren yes, Chorpenning absent, Hupp yes.

Case JC016-14 at address 10758 Rankin RD. There is a green semi-truck. There is no engine, no tires and the vehicle has not been moved in 90 days. Trustee VanBuren made a motion for the zoning inspector to proceed with sending the resident a letter requesting the residents remedy the situation. Case will be reviewed at December 9th meeting. Trustee Hupp seconded the motion. Roll Call vote: VanBuren yes, Chorpenning absent, Hupp yes.

The next junk car meeting will be on December 9th at 7pm. All cases will be reviewed at that time.

Trustee Hupp made a motion to adjourn the meeting. The motion was seconded by Trustee VanBuren. With business complete the board adjourned at 7:20pm.
