## BOWLING GREEN TOWNSHIP

### BOARD OF TRUSTEES

Held September 30, 2014

Bowling Green Township Board of trustees opened this regular meeting at 7pm with roll call. All trustees and Fiscal Officer (FO) were present.

**VISITORS:** Tim May, Jack Hedges, Barb Selegue, Sally Bryan, Iris Hedges, Pete Smith, Russ Chorpenning, Nancy Chorpenning.

**CORRESPONDANCE** Trustee Chorpenning asked why the park committee has been removed from the agenda. FO stated she could put it back on if the board would like it to be on the agenda. He is concerned about the letter that went out on behalf of the board because it wasn't approved by the board. The letter states the township is doing a project when really the township has applied for a grant to do the project. The project has not been approved.

### **REPORTS**

**ZONING INSPECTOR** Barb Selegue, zoning inspector reported she issued 2 permits for the month and she has received an application for variance from the Sorg family. She also mailed 3 junk car letters from cases discussed at junk car meeting.

**UNFINISHED BUSINESS** The date for the case CMI vs Bowling Green Township is set for October 9<sup>th</sup> at 2:30 in Branstol's courtroom.

**NEW BUSINESS** FO had a resolution to accept the county budget rates. Trustee VanBuren made a motion to accept the resolution. Trustee Hupp seconded the motion. Roll Call: VanBuren yes, Hupp yes, Chorpenning yes. The full resolution is on file with the FO.

Trustee Hupp said while the employees were doing some work on a ditch at the corner of Beech and 1<sup>st</sup> St., they hit a resident's line for his invisible fence. Trustee Hupp made a motion to cover the repair of the fence in the amount of \$107.14. Trustee VanBuren seconded the motion. Roll Call: VanBuren yes, Hupp yes, Chorpenning abstain.

### **PUBLIC COMMENT**

Barb Selegue asked why would we have a park committee report if there is no park committee. Trustee Chorpenning said he would like to know about the rentals of the building.

Barb Selegue asked about the checks listed for 2 townships. FO stated those checks are for the fire department payment.

Jack Hedges said the house on the hill in Brownsville that caught on fire has changed owners. No one seems to be doing anything about cleaning it up. There is nothing in zoning about dilapidated structures.

Trustee Hupp made a motion for Brownsville to have their trick or treat on Thursday October 30 from 5-7. Trustee VanBuren seconded the motion. Roll Call: VanBuren yes, Hupp yes, Chorpenning yes. There will also be a trunk or trick in the township parking lot.

Trustee Chorpenning made a motion to pay the bills; sign purchase orders and blanket certificates, and the bank statement. Trustee VanBuren seconded the motion. Motion Carried. It is lawfully certified that the amount \$47,883.88 is lawfully appropriated to pay the bills by the fiscal officer.


