<u>CORRESPONDANCE</u> FO had the proposed text amendment from the zoning commission. The trustees discussed when to hold the public hearing. The zoning inspector discussed the continued violation of the Wess property. Trustee Hupp made a motion to request the assistant prosecutor to proceed with the violation of the 1988 court order against Mr. and Mrs. Wess. Trustee VanBuren seconded the motion. Roll Call vote: Hupp yes, VanBuren yes, Chorpenning no.

<u>UNFINISHED BUSINESS</u> FO stated the board needs to choose the spring collection date for the tire grant. The fall date is October 24th, 2015. Trustee Hupp made a motion to have the spring tire collection on April 16th, 2016. Trustee Chorpenning seconded the motion. Roll Call vote: Hupp yes, VanBuren yes, Chorpenning yes.

Trustee Chorpenning said there was a motion made in April 28 2009, made by Trustees Watkins and seconded by Trustee VanBuren. The motion stated "we put in any new culverts and replace old ones. Trustee Chorpenning would like to look into the information on the culvert installation.

PUBLIC COMMENT

Ron Duval asked if Trustee Chorpenning has attempted to pay back the money spent on re-installing the merry-go-round and if not why. It cost the township money to put it back in when it shouldn't have been removed. Trustee Chorpenning said Mr. Duval's information doesn't match the facts of the situation.
