BOWLING GREEN TOWNSHIP BOARD OF TRUSTEES

Held December 29, 2015

Bowling Green Township Board of trustees opened this special meeting at 7:00pm with roll call. All trustees and Fiscal Officer were present.

CORRESPONDANCE Tr. Chorpenning said he had a letter from Mr. Wess. He scanned and sent it to the FO for the record. He felt it should be read aloud.

REPORTS

SAFETY

ZONING INSPECTOR Zoning inspector was present and reported. She issued 1 zoning permit to Patrick Grapevine at 10989 Open Woods for an accessory building. There was also a variance presented to the appeals board which was approved for the property on Bryson RD. 15682 Main St and 15487 Main St have received letters from the health department requesting the owner clean up the property. 16246 Laurel Hill Rd will be inspected by the health department again in January. The health department gave the zoning inspector some photos of the property. The health department representative also said the residents of the property stated to her that they are running a business and plan to retire. The zoning inspector would like the trustees to vote on this situation in January.

The issue on the vacant alley in Brownsville has been tabled. The trustees are still looking into the situation.

UNFINISHED BUSINESS Trustees discussed the situation on Somerset RD where there has been complaints of obstructions in the right of way. Trustee Hupp made a motion for Trustee Chorpenning to remove the items in the right of way. Trustee VanBuren seconded the motion. Tr. Hupp moved to amend the motion for Chorpenning to contact the resident before he removes the items in the right of way. Tr. VanBuren seconded the motion to amend. Roll call vote: Hupp yes, VanBuren yes, Chorpenning no.

NEW BUSINESS Trustee Chorpenning moved to accept the resolution eliminating health insurance for township officers and full time employees. Trustee Hupp seconded the motion. Roll call vote: Hupp yes, VanBuren yes, Chorpenning yes.

PUBLIC COMMENT

Geary Stepp handed Tr. Chorpenning a letter from the health department. The letter states the health department inspected the property and determined there were no conditions present that could be considered a public health nuisance.

Tr. Chorpenning asked if the letter from the Wess will be read into the record. Barb Selegue feels the letter doesn't pertain to township business. Patty Wess feels things should be cleared up since the false statements made about them were made at a township meeting.

Ron Duval said he thinks Trustee Chorpenning still owes the township money to reinstall the merry go round.

Barb Selegue says the letters on the hurricane spinner should be removed.

BJ said he has a flag he could donate to replace the one in the park. Trustee Hupp said the township has one on order.

Patty Wess feels the statements made about them should be retracted. Tr. Hupp doesn't feel this is a township issue.




