REPORTS

SAFETY Trustee Chorpenning questioned the 'No through Trucks'. He asked the FO if she ordered them and Jack Hedges said he purchased them at the request of the sheriff. FO said the board needs to vote on the proposed text amendment to the zoning resolution which would change the requirement for the road frontage in lots over 20 acres. Trustee Hupp made a motion to accept the proposed amendment to the zoning resolution. Trustee VanBuren seconded the motion. Trustee Chorpenning read the amendment. Geary Stepp disagrees with the 60 foot of road frontage and also thinks the realtor on the zoning board should not have been allowed to vote because he will benefit from this. The zoning inspector said this came from the planning commission. Trustee Chorpenning said he has talked to some residents that this will have a negative effect on. It will make it harder for someone that doesn't' have the required road frontage to split off and see their land. Trustee Chorpenning moved to amend the motion to add the word 'NOT' in from of be and after shall so it reads, Lot area of exclusive of right of way and shall not be in addition to easement of record. FO stated that this came straight from the planning commission. Trustee Hupp asked when the deadline is for the vote. FO said they are running out of time. There was no second to Trustee Chorpenning's amendment to the motion. Trustee Chorpenning moved to amend the motion to instead of 60 feet, it would read 20 feet. There was no second to that motion.
