
Ron Duval asked if the trustees know when the bridge will be repaired. The trustees said there has been a change in the county engineer's office and the schedule hasn't been updated.

Judy Cottrill would like to know if it's possible to vacate the alley by their house. Tr. Hupp said they would look into it and let her know.


Bob Wess asked the trustees to fix Rankin Rd. He said it is ruining their vehicles.
