

PUBLIC COMMENT


Ed Monroe informed board that Licking Township is now planning to start contacting residents if they possess a junk car on their property.

Trustee Glaub made a motion to adjourn the meeting. Trustee VanBuren seconded the motion. With business complete the board adjourned at 7:46pm.




