Shannon Duval asked if it was possible to do some ditching along the roads so the water will run off better. The water running along the road instead of in the ditch is not good for the roads.


Trustee Hupp made a motion to adjourn the meeting. Seconded by Trustee VanBuren. With business complete, the board adjourned at 7:45pm.
