REPORTS

Safety Getting low on cinders. Trustee Hupp talked to someone about hauling me. Trustee VanBuren said he still has some at his property. They will try and get some delivered in the next few weeks.

ZONING INSPECTOR Barb Selegue reported 11334 Mt. Hope RD asked for a building permit but they don't have their well and septic decided on yet. She informed them they will need to get that done before she can issue a permit.

She talked to the assistant prosecutor attorney about the Wess situation. He will prepare a motion to cause force in the original injunction. The court will set up a hearing so each side can voice their side of the situation. The township will need to have neighbors there to attest to the problems.

Resident on Honda Hills RD has at least 15 cars. He says he owns all of them. He told her he is waiting on salvage titles on them.

She received about 10 calls from refinancing companies asking about zoning regulation.

Residents discussed the situation with Gary Stepp's property. Zoning inspector said he wanted to take care of Wess' case first.

Trustee Hupp said he received a call from a resident in Loan Oak Division complaining about his neighbor's goats because their area is not agricultural. Zoning inspector said it's a separate housing addition and the residents of Loan Oak would need to create regulations and enforce them

UNFINISHED BUSINESS Snow plowing went better this month. The trustees didn't receive any complaints. Trustee Glaub thanked Don Watkins for his time plowing the roads.




Trustee Hupp found out they will be replacing the bridge on Mt. Perry RD so it will increase traffic on Rankin Rd.
