Trustee Hupp talked with someone about a new truck at state bid price. It will run around \$70,000.

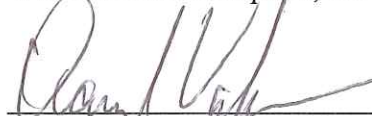
Trustees would like to look into building a new cinder bin.
