
NEW BUSINESS Trustee VanBuren made a motion to accept permanent appropriations as presented by the FO. Trustee Mack seconded the motion.

Trustee Hupp made a motion to adjourn the meeting. Seconded by VanBuren. With business complete the board adjourned at 7:53pm.




