She reported our zoning resolution considers semi-trailers as large storage containers and will require a permit. She also discussed a lot split with the residents at 10213 Honda Hills RD.


The township received a letter requesting the minimum lot size be reduced.


The Wess property has been improved. The zoning inspector took photos as requested by the court.
