Trustee discussed the township's fire officer position. Trustee Hupp feels each of the 3 fire departments should have their own officer which serves their designated area of the township. Trustees will discuss further.


SAFETY Trustees discussed the purchase of a large blower to blow cut grass out of the road way.

NEW BUSINESS Trustees discussed more funds available similar to the Cares Act Funds. Board discussed whether or not they should apply. Trustee Mack made a motion to apply for the funds. Trustee VanBuren seconded the motion. All in favor.
