Held January 4, 2021

Bowling Green Township Board of trustees opened this organizational meeting at 7:00pm with roll call. All trustees and Fiscal Officer were present.

Trustee VanBuren made a motion for Trustee Hupp to act as president for 2021. Trustee Mack seconded the motion. All in favor

Trustee VanBuren made a motion for Trustee Mack to act as vice president for 2020. Trustee Hupp seconded the motion. All in favor.

Trustee VanBuren made a motion for meetings to remain the last Tuesday of the month at 7pm. Trustee Mack seconded the motion. All in favor

Trustee VanBuren made a motion for the agenda to remain the same. Trustee Mack seconded the motion. All in favor

The board discussed the pay rate of the employees. Currently the road workers are receiving \$13 per hour. Trustee Mack made a motion give them a raise of .50. Trustee Hupp seconded the motion.

The board discussed the pay of the zoning inspector, Barb Selegue. She will remain on salary at \$350 per month. She will be reimbursed for mileage and phone at \$25/month. Trustee Mack made a motion for this to remain the same. Trustee VanBuren seconded the motion.

The board discussed the current zoning permit fees.

Cell phone tower one-time permit fee \$1000

Lot split fee is currently \$500 for any split any resident owning the property for less than 5 years.

Current variance fee is \$200

New build – Primary residence \$250, accessory building \$175

Addition \$175

Culvert Permit \$200

Trustee Mack made a motion to change fees as above. Trustee Hupp seconded the motion.



Trustee Mack made a motion permitting the fiscal officer to transfer money within the same account as she feels is needed. Trustee VanBuren seconded the motion. All in favor.


