Bowling Green Township Board of trustees opened this regular business meeting at 7:00pm with roll call. All trustees and fiscal officer (FO) were present.

Trustees opened road bids. The board received 2 bids. Small's is \$56,543.65 and Russell Standard's is \$59,237.50. The board discussed bids and realized, due to misinformation given by FO, they did not bid it with #8 limestone. Trustees will put it out for bid again and open bids on July 17th 2023 at 7pm. They would like to add more roads to the bid, bid separately per road. They would like prices on Coop Lane, Shelly to Bob's Driveway, Gutridge from Shelly to tower, Carmel CT.

Trustee Hupp made a motion to pay the bills; sign purchase orders and blanket certificates, and the bank statement. Trustee VanBuren seconded the motion. Motion Carried. It is lawfully certified that the amount \$19,386.28 is lawfully appropriated to pay the bills by the fiscal officer.


Public Comment: Carla Smith thanked the township for picking up the old tires that were dumped and for mowing along the side of the road.

Alicia Burrows asked if she need a permit for a fence. Zoning inspector informed her she does not need one.


Trustee Hupp made a motion to adjourn the meeting. Trustee VanBuren seconded the motion. With Business complete, the board adjourned at 7:59pm




