National Trails invited the trustees and fiscal officer to the Christmas dinner in January. **Zoning:** Zoning inspector Jack Ward reported he fielded 6-7 phone calls. The whiskey company has filed an appeal with the county since the appeals board denied their application requesting conditional use for 19 storage buildings. He reported there was a lot split on a property on Mulberry.

Trustees discussed zoning amendment. Trustee Hupp made a motion to table the decision until special meeting on December 11th. Trustee Vanburen seconded the motion.

Trustees will need to hire a new zoning inspector since Jack was elected as trustee.

<u>Unfinished Business</u>: Trustees met with architect to discuss drawings. For them to adjust the drawings and apply for county permits will be \$5750. Trustee Mack made a motion to hire Northpoint to adjust drawings and apply for county permits. Trustee Hupp seconded the motion.

The board discussed the information from the county prosecutor's office regarding the passing of the marijuana bill in Ohio. Trustee Mack made a motion to prohibit any adult use cannabis in the township. Trustee Hupp seconded the motion. All in favor.
