Unfinished Business: Electric and plumbing are mostly done in new building. Drywall has been started. Trustees noticed the plans had the incorrectly type of furnace for the office/bathroom area. Trustee Hupp has talked to the contractor about getting the correct furnace and will find out what the cost difference will be.

Park National Bank will have paperwork ready to sign. Trustees discussed having a special meeting to sign paperwork but decided to just move regular meeting to December 16th at 7pm due to the holidays.

Public Comment Carla Smith asked if the trustees knew when the meeting will be with the mediator and Middle West. There has not been a date set. Carla also asked if any residents would be able to attend or if there will be any notes taken of the meeting. Trustee Hupp said, according to the assistant prosecutor, residents are not allowed to attend and there will be no notes or minutes taken. 




residents of the township should have an opportunity to voice their concern or be informed of what is said.
