Held January 2, 2025

Bowling Green Township Board of trustees opened this organizational meeting at 7:00pm with roll call. All trustees and Fiscal Officer were present.

Trustee Ward made a motion for Trustee Hupp to act as president for 2025. Trustee VanBuren seconded the motion. All in favor

Trustee Hupp made a motion for Trustee Ward to act as vice president for 2025. Trustee VanBuren seconded the motion. All in favor.

Trustee Hupp made a motion for meetings to remain the last Tuesday of the month at 7pm. Trustee Ward seconded the motion. All in favor

Trustee Hupp made a motion to keep meeting agenda the same. Trustee Ward seconded the motion. All in favor

Trustee Hupp made a motion for all fees to remain the same. Trustee Ward seconded the motion.


Board discussed paying zoning board members. They will continue to receive \$15 per meeting attended.



Trustee Hupp made a motion permitting the fiscal officer to transfer money within the same account as she feels is needed. Trustee Ward seconded the motion. All in favor.


